2. Site Visit is **MANDATORY**.


Thereafter the bidders were shown the site. The site visit was led by the project Engineer and the following were clarifications

	Another representative asked if there shall be an extension of the closing date and time.	➤ Head of procurement –responded that the closing date and time shall remain 6 th March ,2023 at 10.00Aam.
