Discussions

The meeting began after a brief introduction, the secretary explained that;

The Director of Support Service gave a brief background on the Pretender Site Meeting stating that it presented interested bidders with the opportunity to seek clarification on the tender as it was expected that they had gone through the tender document as they had enough time between the tender advert and the meeting.

The head of procurement took the members on a brief of procurement procedures and guidelines of the tender document. The following were the key points to note:

1. The closing date will remain 1st December, 2022 at 10.00am
2. Site visit is MANDATORY

There after the bidders were taken round the site. The site visit was led by the Project Engineer and the following were the clarifications:

- Length of the stretch for construction.
- Site clearance
- Stone pitching works
- Placing and compaction of hardcore materials to level the ground.
